DEPOSITS AND PAYMENTS

Due to limited availability, seats are strictly limited, to confirm your place on the tour, please forward the completed booking form and a non-refundable deposit of \$500 per person to secure your place(s). In the unlikely event the tour does not reach minimum numbers to proceed, your deposit shall be refunded in full. Payment of the remaining balance is required by 14 February 2025. Payments by Credit Card are subject to Merchant Fees. If paying by cheque please allow 5 working days for cheques to clear prior to due date.

CHANGES TO THE ITINERARIES

Changes to confirmed arrangements will incur a transaction fee and are subject to any supplier charges and conditions. Contact Go See Touring for details.

CANCELLATIONS AND REFUNDS

All cancellations must be advised in writing. Once full payment has been received 100% cancellation will apply to all arrangements. Additional airline cancellation fees may apply if internal airfares are issued. All cancellation fees are subject to change at the discretion of airlines, hotels and other suppliers. Deposits are non-refundable.

TRAVEL INSURANCE

A passport is no longer required for Norfolk Island however it is recommended. You may use any photo I.D. Please provide a copy of your I.D. when returning your booking form. Failure to do so may result in airline re-issue fees been charged. It is passenger's responsibility to ensure all details are correct. For further clarification regarding your passport or visas please contact Go See Touring. Non-Australian Passport holders should check with their consulate regarding Visa requirements.
